To pick orders according to customer requirements by operating electronic pallet trucks in a warehouse environment (cool and ambient).

- Report to management any obvious poor quality stock.
- Handle stock in a manner that will ensure its maximum integrity.
- Handle stock in a manner that ensures stock will not be damaged in loading or in transit.

Customer Satisfaction

- Take responsibility to ensure that wherever possible a store receives all stock ordered.
- Ensure that all orders are accurately compiled, carefully stacked on pallets and placed into allocated lanes.
- To assist in any area as directed to ensure customer satisfaction.
- Operate machinery within established guidelines.
- Audit loaded pallets against specifications.
- Ensure 100% accuracy within picking, loading and forklift duties

Performance Management

 Actively participate in performance management and review process and take ownership of personal development.

Problem Reduction

- Identify potential problems and solutions, within own area of responsibility to management
- Physical Components
- Will be required to work in an ambient and coolroom environment of approximately between 0-15 degrees Celsius.
- May be required to work shift work and weekend as well as at times required to work reasonable overtime.
- Regular manual handling is involved with the requirement to lift stock up to 20kgs in weight.
- May be required to perform regular bending, repetitive lifting, push and pulling.
- Operate pallet truck to move stock from its location on a pallet to the staging area.
- Required to shrink wrap pallets once in staging area.
